CLEAN UP AND REMEDIATION OF THE FORMER CAMP IPPERWASH

The Chippewas of Kettle & Stony Point First Nation as part of the Implementation phase has hired a Project Engineer. The FSA Project Engineer is directly responsible for overseeing the clean-up of Stony Point. The clean-up includes the removal of all unexploded ordnance and bombs, the environmental remediation of the water and soil, and removing all infrastructure, all the while ensuring that the significant number of species at risk are not adversely affected by the clearance activities. All of this work must be done in strict observance of our Cultural Protocols

The clean-up project will take a long time, likely in excess of 10 years, and the planning for the clean-up effort is well underway. Part of the planning process includes the development of a Land Use Plan for Stony Point.

FORMER IPPERWASH PROVINCIAL PARK


The process for returning the Park lands to the First Nation was committed to by the provincial government in 2008.

We are working with the provincial government and their departments to work through the Additions to Reserve (ATR) process. This has been ongoing for several years, but we are finally in the drafting of the Tripartite Land Transfer Agreement between the First Nation, Canada and the Ontario.

PROPERTY MAINTENANCE AGREEMENT (PMA)

This is an agreement with the government of Canada to maintain the property at Stony Point to ensure the health and safety of the First Nation members that reside there, as well as the contractors that do clearance and remediation work there in order for the land to be acceptable to transfer to the First Nation.

First Nation members are employed under this agreement.
